## Dea Code A

Further to your letter dated 13th November I can confirm that there was an internal investigation into this gentleman's care following an alert raised by Hampshire Constabulary in September 2012. Prior to this we had only been aware of the family's dissatisfaction last January when the gentleman was an inpatient and a number of his personal belongings went missing. We had started to address their concerns through the complaints process and they had further added some concern about whether Mr Willemse was getting adequate nursing time and care. However in February before we completed our investigation Mr Willemse passed away and his next of kin asked us to stop our investigation. We did, but we offered them an open door to come back to us. The next we knew of them was through the concerns they raised to the police about missing items and similarly to the NMC referral about medications used in

We have been investigating those concerns and I attach our outline report which we have shared with the police - we have also offered to meet with the family to share our findings but they have declined preferring to wait the outcome of the police enquiry and your NMC findings.

Having received the details from the NMC we now intend to revisit the report and look into any further allegations not covered within the report - however I will note that thus far no fitness to practice concerns have been found.
