# Patient's prognosis

- likelihood of patient entering a 'natural' irreversible terminal decline:
  - o unlikely Enid Spurgin (BJC/45); Geoffrey Packman (BJC/34); Elsie Lavender (BJC/30)
  - o difficult to judge (significant co-morbidity present) Helena Service (BJC/72); Ruby Lake (BJC/67); Sheila Gregory (BJC/21); Elsie Devine (BJC/16)
  - o likely Leslie Pittock (BJC/71); Robert Wilson (BJC/55); Arthur Cunningham (BJC/15).

Note: prognosis is difficult to accurately judge and it is best to consider the above an indication, in my opinion, of which end of a spectrum a patient would lie rather than a more definite classification.
