We understand that you are investigating the deaths of 10 Patients from the Gosport War Memorial Hosp during the 1990's.

My Parents death was 1996 and 1999 and both of them were involved in a Police investigation with Alexander Harris and "Operation Rochester"

Mother died in 1996 Mykin attached to her for which we were misled was just a Mild relative we were told. He died a few days later.

then dad a very active man who was still digging his garden upright strong character. lasted only from 1st June 1999 to the 2nd June 1999.

he had left Asta Hospital for an overnight stay in the War Memorial we were there with him when I discovered a Needle in his neck.

and there was a funny weird atmosphere with staff who wouldn't speak to us on our arrival

The Building was separate from the rest of the hospital. We know there chlorine was hastened and we cannot Move on without a Coroner's inquest since there deaths have devastated my sister and I and I am terrified of hospital treatment since knowing this

My husband suffers Breathing Problems and is concerned as to whether our Parents are included in the 10 Patients you are investigating

since we've had no mention that they are included and if not 'Why' since 1997 I have paper work concerning them.

Please can you confirm as to if our Parents are listed in your Title to Be Investigated. If not should we get in touch with medication IV etc we feel very strongly its very necessary for us since my husband was admitted into hospital.

I was terrified for his safety and stayed almost all night watching what was given in and when I had a serious cancer operation myself I fought with my life to survive and had no Morphine for pain relief for I thought they were doing what was done to my Mum & Dad

so Please include our Parents so we can move on which is something we cannot do right now.

I can arrange to come down for an interview with you if you give me 48 hours notice to do so or Perhaps you could ring me after 4.15 pm on the above number in the next few days
