#### **EXPENSES INCURRED DURING YOUR JURY SERVICE**

#### Expenses claims forms will be sent to you in February 2009.

You will be entitled to claim reasonable expenses that result from your service as a Juror. Payments will be made after each week of your Jury Service, as soon as possible after your claim is submitted.

The maximum amounts that the Coroner is permitted to pay are as follows:

- Mileage will be paid at 28p per mile
- Any public transport fares will be paid in full, but do not include first class fares, taxi or private hire fares, which will be paid at the ordinary public transport rate.
- <u>Subsistence</u> (for refreshments purchased during the day) will be paid to a maximum of £4.75 per day.
- Financial Loss Allowance, which covers earnings that will not be paid by your employer, or child care expenses that might be incurred, will be paid to a maximum of £65.60 per day.

No payment will be made without proof that you have incurred a financial loss.

Proof of financial loss will be provided by completion by your employer of an official form that will be sent with expenses claims forms in February 2009.

If you are self-employed, some evidence of loss you will incur as a result of your Jury service will be required.


A claim for any other financial loss, for example payments for child care, will need to be supported by valid receipts.
