Dear Suzie.

Why did I think I had done that already? Maybe it just seems like it.

'The Gosport Memorial Hospital Inquests are ten Inquests ordered to take place by the Secretary of State to examine the deaths of ten patients at the Hospital who had been transferred there for rehabilitation or paliative care. All the deaths under examination occurred between 1996 and 1999 and all involve the administration of opiate analgaesia. The concerns expressed by the families of the deceased are the use of syringe drivers to administer the drugs and the dosage administered.

I shall be sitting in Portsmouth Combined Court Centr from 18 March and the case is scheduled for six weeks. I shall be sitting with a jury and evidence will be taken from the families of the bereaved, nursing staff, clinical staff and two experts with particular knowledge of geriatric and palliative care.

The jury will need to revisit the cause of death, the circumstances of the death and to give a conclusion or 'verdict'. The jury is not permitted to examine any question of criminal or civil liability and the Coroners Act specifically precludes them from doing so.

The Inquests will provide an opportunity to examine the workings of the hospital between 1996 and 1999 particularly so far as these ten deceased are concerned and will give those concerned the opportunity to ask the questions that have remained with them since the deaths and I sincerely hope will give them answers to those question within the remit of the Inquest process'
