As she got older he did suffer from gout and leg ulcers. This caused her quite a bit of pain. These were something that she would have regular treatment for. The other thing she suffered from was arthritis. She had various aides in the house to help maintain her quality of life. Her mobility was limited and she did not go out on her own.

However there were things that affected her in the later stages of her life. Mum didn't drink or smoke and I would say that she was a fit and healthy woman for her age. Her GP was local and was Dr NORTH, he was with the Surgery in Stoke Road.

In late July 1998 mum had a fall whilst at home. She was alone at the time but was able to contact a friend who was in turn able to call the police who broke down the door and called for an ambulance. As a result of the fall mum broke her hip and was taken to the Royal Haslar Hospital. She underwent surgery later that day and was given a new hip.

I was able to see mum later that day, she was post op so I didn't spend a great deal of time with her I just made sure she had what she needed. Mum stayed in Haslar for about 2-3 weeks. I would visit her most days.

Whilst mum was at Haslar I never saw her out of bed. It was clear that the operation had had quite an effect on her. Her mood could go up and down and there would be periods when she didn't talk, although she could be quite lucid and was able to hold a conversation.

I think at this time mum had developed a cough and there was a question mark over fluid on her chest. As a result I think she found the meal supplements easier to digest than normal food and was quite happy with these.

On being told that mum was going to be moved to the Gosport War Memorial Hospital, I raised concerns with staff at Haslar that I felt mum was not yet well enough, I think I spoke with a nurse but I don't recall who. I was assured she fit to be moved and on the 17<sup>th</sup> August 1998 (17/08/1998) mum was moved to the GMWH. This was on Monday.

I went and saw mum on the Tuesday (18/8/98) (18/08/1998) she was in a private room and appeared to clean and well cared for. She was able to talk and I can't recall any concerns. Mum had numerous visitors, family and friends. My initial view was that I did not expect a fall and a hip operation to cause the demise of mum. However I was realistic enough to realise that the trauma of the fall and subsequent surgery could take its toll on an elderly woman, which became more apparent as the weeks went by. Up until late Wednesday (19/08/98) (19/08/1998) when mum appeared to become quite agitated and distressed I still felt there was a good chance mum would be coming home.

I had been able to talk to mum on the Wednesday but by the Thursday there was a noticeable deterioration. She gave no visible signs and was unable to respond either through hand gestures or oral communication. I can't be sure at what stage it was started but I think mum was on a syringe driver at this stage.

When I saw mum on the Thursday both my sisters were with me, as well as my brother-in-law and my husband's parents. Other friends from church would also visit. I spent most of the day with her on the Thursday and went to see her again on the Friday.

I found the hospital staff to be helpful with regard to allowing us to stay, they seemed quite caring but I don't recall talking to anyone in any great detail about mum's condition. By the Thursday we were all aware that mum was very ill and we didn't expect her to last that much longer.

On Friday 21<sup>st</sup> August 1998 (21/08/1998) I spent the day at the hospital with mum. My husband his parents were also there as was his sister and niece as well as my sister Pauline and her husband Graham.

Mum seemed quite peaceful during the day and was to all intents and purposes asleep. She died in the early evening with the family close by.
