Dear Dave,

As with the current hearing, I will make the key for the room available for your office.

Water jugs, I'm afraid you'll have to sort this out with restaurant, we do not have any to provide.

The hearing loop system is an integrated part of the council's audio system. A receiver "necklace" picks up the Infra-red signals within the chamber and transmits to the user wearing a hearing aid,

or can be worn as a set of headphones. We have number of these in the Chamber and such should not be an issue keeping a number of them constantly fully charged for the duration of your hearing. I will of course nearer the time, would like to discuss these matters with whoever will be assisting you for you hearing so that they know how the microphones and hearing loop equipment and system works.

As you may note from my previous emails below, I'm sorry that a meeting of the full Cabinet has been moved and apologise for this. It was something beyond our control and fully appreciate your helpful flexibility in this.
