I don't know if you are aware that there will be another Inquest in the system now. The Coroner has agreed, after much discussion, to do a separate Inquest for the family of Gladys Mabel RICHARDS - DOB: CodeA . She died at the Gosport War Memorial on 21/08/98 (she fell and fractured her hip at home, underwent surgery at Haslar and was transferred to GWM where she then died) A Doctors certificate was issued at the time.

The Coroner has requested that the Police supply him with all the background documentation that they have, regarding Mrs Richards. I think that the police are still holding alot of paperwork regarding the GWM investigation. The other suggestion is that this documentation could also be amongst all the file that was recently in Court. HMC has suggested that it may be best for a police officer who knows their way around the case / file to locate the paperwork, as they have a better understanding. He suggested that the best person maybe the officer who was in Court for the recent GWM cases. I believe that this was you?

Roy, are you in a position to obtain this documentation for us? As previously stated, it may be amongst all the papers that the police still hold?

I am really sorry about this (I 'm sure you thought that that was all over with) ??!! If you are able to help, could you let me know and If you need to come over to our office to go through the file, just give us a call <u>Code A</u> / <u>Code A</u> / <u>Code A</u> .
