Dear Lisa

Further to the attempts to arrange a date for the inquest, I wonder if I can suggest a way forward, which you are welcome to put to others if that would assist.

As you know, I have previously advised that within the period put forward by the Coroner, only the period 13<sup>th</sup> February – 1<sup>st</sup> March is available.

I appreciate that may not be available for everyone else.

To assist, can I propose that the Coroner allocates a period – perhaps a week – within those dates. A number of witnesses could then give evidence, Dr Barton included. Dr Barton can then be released as a witness.

Anticipating that single week will not be long enough, a further a week could be set aside in the period 25<sup>th</sup> March – 12<sup>th</sup> April. Dr Barton cannot attend then, but both Dr Barton's barrister and I will be able to represent her.

Please do let me know if that might help in any way, and if I can assist further.
