I write further to our telephone conversation late afternoon and confirm that I am instructed by Hampshire Primary Care Trust in relation to the inquest to be held into the death of Gladys Richards which I understand is listed 9 April 2013. I was the solicitor that represented the Trust at the inquests held in relation to the deaths of 10 patients before Mr Bradley on 18 March 2009. You may be aware that Hampshire PCT assumed responsibility for services at Gosport War Memorial Hospital in October 2006 and that included responsibility for Dryad and Daedalus wards.
