Gosport Inquests

We write further to our telephone conversation (Knowles/Flurry) of 18 December and your letter of 14 November.

Please once again, forgive our delay in contacting you in this matter but we have been reviewing this in some detail with our client. We can confirm that we are instructed on behalf of Portsmouth Hospitals NHS Trust and Hampshire PCT. In fact there are a number of other PCTs involved and although we are not directly instructed by them we are the firm instructed to represent the interests of "the NHS as a whole" in Hampshire.

We note that you are instructed by the MPS and there are two MPS members involved namely Dr Robert Logan and Dr Elsa Lord.

We confirm our telephone conversation that we do not believe there is conflict between the members of the clinical staff you represent and the NHS as a whole. The NHS is content that we should offer support to Drs Logan and Lord. In fact we recently met Dr Logan at a briefing meeting for clinical staff at the hospital.
