You will remember that I have been planning to set up a study to pilot methods of presenting mortality data to GPs and helping them develop practice policies to reduce mortality and improve outcomes. We had applied for for from the Nuffield Trust, but because of the stock market problems they did not have funds available.

However, we applied to the NHS SDO Programme and have heard that we have gor through the first round. The full application must be submitted by 11th September, so I will be working on it over the summer. We will be needing to call on the ONS for data - the ethics forms have already been completed and approved, as has LREC approval. We will be needing advice about costs, but are not yet ready to ask for details. Nevertheless, I thought it would be helpful for you to have advanced information, and an update on our progress.
