Please find attached the list of patient's whose deaths were investigated by the Police (Operation Rochester); information listing nursing + anc staff involved in the care of named patients at GWMH and the Coroner's press release which contains the names of those who he has opened and adjourned inquests on.

We don't know which clinicians the Coroner might want to contact but the Dr and MDT list attached is of those people the GMC were going to contact for their hearing so might be indicative. I don't have any more details or confirmation of who was contacted because the GMC made direct contact unlike with the nursing staff.
